

IDEOLOGY OF GENOCIDE, POLITICS, AND PRACTICE OF PSEUDO STATE  
CREATION SERB REPUBLIC OF BOSNIA AND HERZEGOVINA, THAT IS,  
REPUBLIKA SRPSKA

The Serb intellectual and political elite, at the end of the 20<sup>th</sup> century, in accordance with its Serb (nationalistic) ideology of territorial expansion – encircling the territory “in which all Serbs live together”, which (ideology) gives the legitimacy to the aggressive war and genocide, aimed at the creation of an imaginary ethnic state – great Serbian state, accepted, supported, and intensively worked on the achievement of the project of the Great Serbia. Principal objective of the political project, genocidal by its character, “**all Serbs in one state**”, which in the history of the Serbian politicians has existed for last two centuries, consists of creation of a great ethnic (Serbian) state, in which “**the entire Serb nation would live**”.

Serbia, during the 19<sup>th</sup> and 20<sup>th</sup> century, for the purpose of achievement of this fascist, Nazi, and genocidal project of national, ethnic, and religious purity, conducted aggressive wars and perpetrated numerous forms of crimes against humanity and international law, including genocide against Muslims in the Balkans (Bosniacs, Albanians...), where unfortunately they mainly received the support of great powers.

The political project – Serb great state project “all Serbs in one state” resulted in an internal crisis in the Socialist Federal Republic of Yugoslavia, destroyed a common state and escalated in an aggressive wars and genocide. Serbia and Montenegro, that is, Federal Republic of Yugoslavia conducted in the period between 1991 and 1999 aggressive wars at the Balkans (a war for a “living space” - *lebensraum*), including the war against the Republic of Bosnia and Herzegovina (1991-1995).

This aggressive project, among others, was embraced and supported by ample political, military, and social subjects in Serbia, Montenegro, Croatia, and Bosnia and Herzegovina, including the nationalists Serb Democratic Party of Bosnia and Herzegovina, who even took part in it.

The implementation of the great Serbian ideology, politics, and practice in the Republic of Bosnia and Herzegovina was in the hands of the Serb democratic party of Bosnia and Herzegovina, under the leadership of Radovan Karadžić, Momčilo Krajišnik, Biljana Plavšić, and other criminals, whose politics was unfortunately accepted by many Serbs. The

leadership of the Serb democratic party and the Serb pseudo state creation in Bosnia and Herzegovina (Serb Republic of Bosnia and Herzegovina/Republika Srpska) was a part of a joint criminal enterprise under the direct political and operative leadership of Slobodan Milošević, whose criminal intention was to, in line with his political project of establishment of a “single state of Serb people” (“single Serb state in Balkans”), occupy the state of Bosnia and Herzegovina and destroy Bosniacs as a national, ethnic, and religious group.

Starting from a great Serbian (criminal) collective ideology and its genocidal “strategic goals” in Bosnia and Herzegovina, the Serb democratic party, ever since its establishment (12 July 1990) until 9 January 1992, not only followed the instructions, guidelines, and orders of the Serb nationalistic regime in Belgrade to declare the pseudo state creation (Serb Republic of Bosnia and Herzegovina), as a “federal unit of the federal Yugoslavia”, within the territorial integrity of the Republic of Bosnia and Herzegovina and its constitutional order, but it also, in line with its title (prefix Serb) and with the active support of the JNA forces (“Army of the Serb people”), disarmed the Territorial defense of the Republic of Bosnia and Herzegovina, then distributed weapons, in an organized manner, and trained Serbs to take an active role in the assuming the (Serb) authority. Also, by increasing the density of occupied territories, they conducted (silent) occupation of a significant part of the (state territory of the) Republic of Bosnia and Herzegovina, openly violating the constitutional system and territorial integrity and unity of the Republic of Bosnia and Herzegovina, and jeopardizing the personal and safety of property of its citizens, while they completely or partly undermining the powers of legitimate authorities. Accordingly, they organized the Serb political authorities – legislative, executive, and judicial in the territory of Bosnia and Herzegovina, even in municipalities where Serbs were minority, which altogether served the function of detailed political, military, intelligence, security, informative, structural, technical, logistical, and psychological preparations for the aggressive war and genocide. The organization and the conduct of following activities were completely unlawful and illegitimate, in other words, those were unconstitutional and illegal activities, which unfortunately have never been punished. Moreover, they openly and publicly announced and incited the violence and force as the only method of seeking solution for already prepared and staged armed conflict. They were organized, coordinated, and synchronized and they directed the criminal activities against the Republic of Bosnia and Herzegovina by the institutions of Serbia in Belgrade, especially the leader of the great Serbian project (Slobodan Milošević) and his fifth column in the Republic of Bosnia and Herzegovina, the instruments, organs, and agents of the state of Serbia, that is, the Federal Republic of Yugoslavia (Serbia and Montenegro), all for the purpose of preparation for the aggression and genocide.

These and other criminal activities, including (genocidal) statements of Radovan Karadžić and other SDS officials on the “disappearance” – extermination of Muslims in Bosnia and Herzegovina and Sarajevo (“**One entire nation will disappear from Earth ...**”; “**...Sarajevo will disappear in two days and there will be five hundred thousand killed. In a month, Muslims from Bosnia and Herzegovina will disappear**”; “**First of all, none of their leadership would stay alive. They would all be killed in three to four hours. They have no chance to stay alive**”), are criminal offenses against constitutional order of the Republic of Bosnia and Herzegovina and they are apparent proof of **genocidal intention** (to commit genocide), which is also characteristic for Sarajevo.

In the course of implementation of a declarative political objective (establishment of a “single state of Serb people”), in this war for the “living space” (in November 1991, Radovan Karadžić stated that his was “**...the war for a living space**”), “liberation” of “Serb territories” and securing “**ties between Serb territories and motherland Serbia**”, the pseudo state creation Serb Republic of Bosnia and Herzegovina/Republika Srpska, along with the state-aggressor Serbia, that is, Federal Republic of Yugoslavia (Serbia and Montenegro), whose armed forces (JNA/Yugoslav Army, Republic of Serbia Police, particularly Special police forces such as *Red berets*, and other armed units) conducted direct combat activities in and against the Republic of Bosnia and Herzegovina and civilians, including Sarajevo. In these operations, the Yugoslav Army officers participated in the execution of children in the territory of the Republic of Bosnia and Herzegovina – **in all the occupied places and towns under siege**, including Sarajevo (in the occupied parts and the part under the siege), and perpetrated grave violations of international humanitarian law – numerous forms of crimes against humanity and intentional law, including genocide against Bosniacs, which is supported by the whole corpus of evidence. Unfortunately, the Dayton Peace Agreement has legalized the great Serbian Nazi ideology, politics, and practice of genocidal character.

The available relevant and valid documents, scientific findings and facts, empiric records, experiential and other knowledge undoubtedly prove and confirm that the entity Republika Srpska is a genocidal creation (of great Serbian Nazism and/or the state Federal Republic of Yugoslavia /Serbia and Montenegro), which emerged on grave violations of international humanitarian law, especially crime of genocide and it is framed and covered with ample mass and individual graves.
